- F. BOARD OF EDUCATION LIASON REPORT Kathryn Russ gave a brief update from the Board of Education. She stated that they are in a deficit for the current year and are in a budget freeze. They approved their budget and there is a 6.63% increase. They are also still looking for a Director of Finance. There is Tri-Board meeting on Monday at 7pm.
